The acceptance of the booking outlined on the booking form once completed is based on agreement by the client of the terms and conditions herein. This contract exists between Steve Shipman Photography and the Bride and Groom, irrespective of who is financially responsible for wedding photography. It is agreed that the terms set out in this contract is the total agreement made between the parties and that no variation or modification of this contract shall be effective unless agreed by both parties in writing.

A nonrefundable booking fee of £500.00 is to be paid on the placement of the booking, and one copy of the signed contract returned to Steve Shipman Photography. Dates are reserved only when the booking fee is paid. The balance outstanding on the wedding package price will be paid two months prior to the date of the wedding. Cheques should be made payable to Steve Shipman Photography. The price of a wedding album and prints is guaranteed at the time of the booking for one year provided that they are paid for when ordered. Albums ordered after one year from the wedding will incur a surcharge. All orders must be paid for at the time of ordering. Overtime attendance on wedding day is £250.00 per hour.

Any client cancelling the booking shall forfeit the booking fee and the same shall remain the property of the photographer. Should the cancelled wedding be a postponement, then, subject to Steve Shipman's availability, all monies paid may be transferred to the new wedding date.

Whilst every care is taken to ensure accurate colours in photographs, the photographer does not guarantee that colours on film, digital medium or in print will exactly duplicate any fabric colour or skin tone. Prints made at different times may be variable in colour balance. Please note that some fabrics react differently in some lighting conditions and can cause colour of the fabric to change, giving incorrect colour beyond the photographer's control. It is sometimes impossible to record photographically colour as it is seen by the human eye.

Although the photographer and his appointed agents shall exercise all reasonable skill, care and diligence in the discharge of their duties, it is understood that in the event of any unforeseen circumstances beyond the photographer's control causing loss of photographic record, the photographer's liability will be limited to the return of all the money paid to date. The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control. Neither party shall be responsible for indirect or consequential loss. Steve Shipman has full Public Liability and Professional Indemnity insurance.

Full artistic licence shall be granted to Steve Shipman Photography during the attendance of the wedding and reception venues. Steve Shipman Photography and his associate photographer's judgement in relation to poses, locations and number of photos taken during the day is at their discretion. Factors taken into account include access, weather, co-operation of the subjects, permissions from venue officials etc. No one photograph will be deemed more important than another. Special requests are not binding instructions, although every effort will be made to comply with the client's wishes. Digital post-production and retouching of image files is at the discretion of Steve Shipman Photography, and retouching beyond that deemed necessary by Steve Shipman Photography may incur fees.
